Were you wounded?

in a heavy undercast

On 11 February 11 1944 we got lost/on our way to FRANKFURT. ~~From the~~

~~flak I thought that we were over the city. Some planes dropped their bombs;~~

~~others did not ~~fall~~ because the lead ship did not drop.~~ We had been told to

take any town in Germany, so we made a run on a good sized town¹ and met accurate and moderately heavy flak over it. Flak burst in our formation.

All four propellers ran away. We left the formation with numbers one and

two engines smoking and fired green-green flares. ~~about~~ The P-47's covered us. For about an hour we followed a formation. Six FW 190's finished us. The pilot ~~passed a verbal~~ ^{because} the inter-com and

alarm bell had been shot out. The engineer jumped first from the escape hatch, followed by the bombardier and me.

I delayed my jump from about 11,000 feet to the clouds at 2,000 feet. I had an easy landing on my seat in the middle of a field. What looked like the whole population of the nearby town turned out to meet me. I thought that I was caught. I gathered up my parachute. The people at first thought that I was German because of my close cropped hair. When I held up my parachute with USA on it, one man grabbed my parachute and another took me to a house. The ~~whole~~ crowd followed. I showed my phrase list, pointed out that I was an American aviator, and asked for civilian clothes. While I was giving out American cigarettes, ~~someone brought me~~ ^{some} civilian clothes, ^{were brought to me.}

In a few minutes a man came for me, and ~~from that place~~ my journey was arranged. Some days later I met Sgt BERGERON and traveled with him.

Sgt BERGERON:

The radio operator, left wing gunner, and I were all hesitant to leave I jumped first at about 7,000 feet, delayed a little, and opened my parachute I landed in a wooded area, saw two of my crew members, and walked over to them. Some people came toward us. When I told them I was an American, they brought us food. They took care of our ^{and}

Appendix B

1. The following information has been obtained from an officer and a sergeant who evaded capture in enemy occupied territory.

2. Further circulation of this information may be made, but in that case it is important not to divulge any details about the source.

Statement of information covering the period from 11 February 1944 to 19 March 1944

a. In February informants saw Me 109's and FW 190's flying from the airfield just outside of CREIL. They saw three batteries of ~~three guns each~~ protecting the field.
 3-544

b. Informants were told that a factory making airplane parts is located at CREIL on the road to MONATAIRE.

c. Informants noticed near St BRIEUC a small airfield quite well guarded and protected by barbed wire.

d. Traveling from CREIL to Paris in early March and from Paris to St BRIEUC informants noticed that most of the railroad yards were crowded with war materials: trucks, bombs, and guns, including 88-mm's.

e. The French seemed very tired and are most anxious for the allied landing. The delay allows the Germans to make effective propaganda.

SUBJECT: Amended Instructions Concerning Publicity in Connection with Escaped Prisoners of War, to Include Evaders of Capture in Enemy or Enemy-Occupied Territory and Internees in Neutral Countries.

TO: The Commanding Generals,
Army Ground;
Army Air Forces;
The Commander-in-Chief, Southwest Pacific Area;
The Commanding Generals,
Theaters of Operations;
Defense Commands;
Departments;
Base Commands;
The Commanding Officers,
Base Commands;
Director, Bureau of Public Relations.

1. Publication or communication to any unauthorized persons of experiences of escape or evasion from enemy-occupied territory, internment in a neutral country, or release from internment not only furnishes useful information to the enemy but also jeopardizes future escapes, evasions and releases.

2. Personnel will not, unless authorized by the Assistant Chief of Staff, G-2, War Department General Staff, publish in any form whatever or communicate either directly, or indirectly, to the press, radio or an unauthorized person any account of escape or evasion of capture from enemy or enemy-occupied territory, or internment in a neutral country either before or after repatriation. They will be held strictly responsible for all statements contained in communications to friends which may subsequently be published in the press or otherwise.

3. Evaders, escapees, or internees shall not be interrogated on the circumstances of their experiences in escape, evasion or internment except by the agency designated by the Assistant Chief of Staff, G-2, War Department General Staff, or the corresponding organization in overseas theaters of operations. In allied or neutral countries, American Military Attaches are authorized to interrogate on escape, evasion and internment matters.

4. Should the services of escaped prisoners of war, evaders, or internees be deemed necessary for lecturing and briefing, such services will be under the direct supervision of the agency designated by the Assistant Chief of Staff, G-2, War Department General Staff, or the corresponding organization in overseas theaters of operations.

5. Commanding Officers will be responsible for instructing all evaders, escapees, and internees in the provisions of this directive which supersedes letter, AG 383.6 (5 Nov 42) OB-S-B-M, 7 November 1942, subject: Instructions concerning Publicity in Connection with Escaped Prisoners of War and other previous instructions on this subject.

- (3) The route you followed.
- (4) Any other facts concerning your experience.

b You must be particularly on your guard with persons representing the press.

c You must give no account of your experiences in books, newspapers, periodicals or in broadcasts or in lectures.

d You must give no information to anyone, irrespective of nationality, in letters or in conversation, except as specifically directed in Par. 4.

e No lectures or reports are to be given to any unit without the permission of A. C. of S., G-2, W. D., or corresponding organization in the theater.

GERTIFICATE

I have read the above and certify that I will comply with it.

I understand that any information concerning my escape or evasion from capture is **SECRET** and must not be disclosed to anyone other than the agency designated by A. C. of S., G-2, War Department, the corresponding organization in overseas theaters of operations, or to the Military Attache in a neutral country to whom I first report. I understand that disclosure to anyone else will make me liable to disciplinary action.
